Background and objectives

According to the IPCC, preventing potentially catastrophic levels of global warming will require the world economy to cut emissions of greenhouse gasses to net zero levels by 2050. This target has already been adopted or is being proposed for adoption in 123 countries around the world, who are collectively responsible for 92% of the world's GDP and 88% of total emissions. However, while ambitious mitigation targets are being set by many countries, achieving them remains a major policy challenge. For designing, passing, and implementing effective climate policies, a proper understanding of the economic and psychological factors underlying human behaviour is of great importance.

To facilitate research for informing effective climate policy design, the iRisk research centre at IÉSEG School of Management, in collaboration with LEM and the University of Lille, will host a multidisciplinary workshop. The workshop will bring together scholars from various disciplines working on the intersection of economics, psychology, and climate change. Ultimately, the workshop aims to:

- · Provide a platform for discussions of theoretical and empirical research exploring the behavioural obstacles for addressing climate change, which can deliver useful insights for how to design more efficient policies and how to increase the public appeal of economically efficient policies;
- · Build interdisciplinary collaborations on decision research into climate policy design and acceptance; and
- · Facilitate structured conversations for identifying critical gaps and opportunities for further research in this area and for encouraging new cross-disciplinary interactions and collaborations.

All invited talks will be given by experts in their respective fields. Theoretical talks will address foundational issues in economic and psychological theories of decision-making. Empirical talks will discuss insights from behavioural economics and psychology focusing on applications to climate policy design and acceptance.
